- 2) Upload labeling with a National Drug Code (NDC) clearly present and legible.
- 3) Request a reinstatement through our standard seller appeal process.

If you are unable to upload labeling with an NDC that is clearly present and legible, you can provide that NDC information in your reinstatement request through the standard seller appeal process. You must upload an ingredient list for the product to be uploaded to be considered for any reinstatement.

If you do not apply for reinstatement and have any remaining inventory of these products in Amazon fulfillment centers after March 13, 2023, you will need to create a removal order for return or disposal of your remaining inventory.

If you do not submit a removal order for impacted ASINs within 30 days of receiving a removal notice, we may dispose of this unsellable inventory in accordance with the Service Terms and policies applicable to your listings.
